Foreword

We've entered Q2 of 2024 following a strong stock market performance in Q1, reflecting strength in the wider US & EMEA economic performance. This has led central banks to be careful in their messages around interest rate drops. As I am writing this, the situation in the Middle East is tense as well. It is as always hard to predict what short term impact on the M&A market will be.

I want to draw your attention to the below publications as well. They will help you form a much more granular view on the state of the world as CEOs see it. We have also included our supply chain monitor. Given how global supply chains are – one can almost view them as the heartbeat of the global economy. Please check its pulse in the below report.

Lastly, we have included a link to a recent packaging study in Food & Beverage. Packaging is critical for food safety, quality and consumer experience and ease of use. Also, good packaging will help reduce food spillage if it allows more reuse and less food waste. However – packaging itself often ends up in our waste baskets or complex recycling supply chains. Optimising net environmental impact, consumer experience and costs is not easy, but really required.

For M&A, deal activity in March involved 101 deals in total; that's an increase of 35 deals year on year. A couple of the notable ones are:

- ABInBev completed the buy-back (0.19%) of its stake from Altria Group Inc.
- Haleon plc repurchased 1.11% of its shares from Pfizer Inc.
- Nolet Distillery and Enix NV acquired around a 7% stake in Lucas Bols NV
- Accrol Group Holdings plc was acquired by Navigator Co through its subsidiary, Navigator Paper UK Ltd.

The most active sector (in number of deals) in March was Accommodation with 19 deals, as shown by (1) Accor SA repurchasing 2.8% of its share from Jinjiang International Holdings Co. Ltd., (2) Connected Capital acquiring Hoteliers.com BV and SmartHOTEL BV and (3) White Rose Hotel Ltd. being acquired by Complete Hospitality Ltd.

Several potential acquisitions and exits are also being explored. To name a few:

- Dutch urban furniture provider for public spaces CReators of the Outside WorlD (CROWD), backed by Tikehau Capital, seeks to consolidate the market by acquiring European peers
- CitizenM, a Netherlands-based boutique hotel operator, is being weighed for sale by its owners

We hope you find this newsletter useful in quickly bringing you up to speed on recent Consumer Market M&A activity.

M&A overview (1/2)


Recent Retail, Consumer and Leisure deals

We see that also in EMEA retail, consumer and leisure there are strong signs of improvement in line with wider M&A market developments. The number and average size of the transactions have increased, which mainly reflect corporate buyers optimizing their portfolio and footprint. For the remainder of the year I foresee growth in the number of announced deals looking at the processes currently underway and in preparation - especially after the Summer and probably with a larger role for private equity.




Deal value €m vs deal volume last twelve months (LTM)




Quarterly deal volume by sector (Apr23-Mar24)

Deal volume by investor origin







Public company valuations by sub-sector




Median trading multiples and stock prices by sub-sector



Top stock price gainers in March 2024




Top stock price decliners in March 2024








